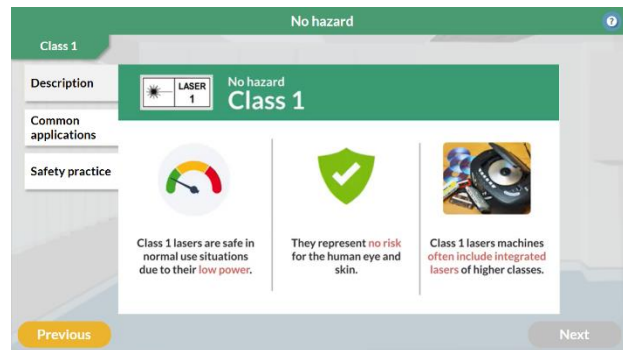

At the end of the training, the trainee will have the ability to:

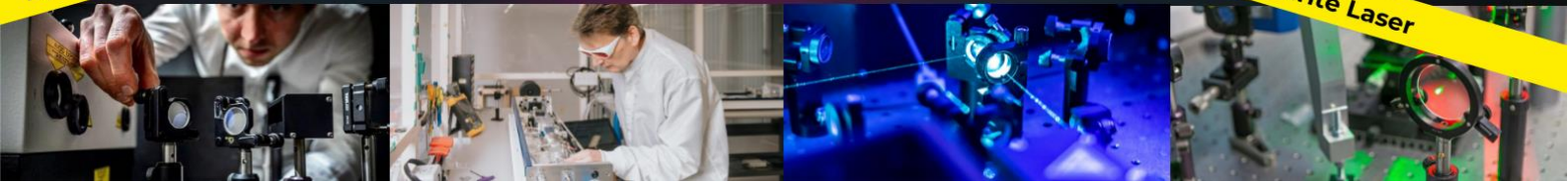
- Identify the main risks associated with the presence of lasers.
